Two or more referees will scrutinize every original or review article submitted to the “Vidarbha Journal of internal Medicine”.

Guidelines for Manuscript Preparations -

1. Original Articles : The Manuscript should be prepared in accordance with the ‘Uniform requirements for Manuscripts submitted to Biomedical Journals’ compiled by the International Committee of Medical Journal Editors (NEJM 1997; 336: 309-315). (Vancouver style)

Three complete sets of manuscript should be submitted, typed in double space on one side of the page throughout (including references, tables and legends to illustrations).

The manuscript should be arranged as follows : Covering letter. Title page. Abstract. Introduction. Methods. Results. Discussions. Acknowledgements. References. Tables and legends to illustrations.

Three sets of the illustrations in three separate envelopes should be attached at the end. The pages of the manuscript should be numbered consecutively beginning with the title page.

Please also submit an electronic version “CD”/soft copy via email along with the printed copies to facilitate the processing.

Covering letter : Covering letter should explain if there is any deviation from the standard IM RAD (Introduction

Methods, Results & Discussions) format and should outlined the importance and uniqueness of the work. All authors must sign the covering letter with the understanding that :

1. All authors have reviewed the article and agree with its contents.
2. The article is entirely original
3. No portion of the article is under consideration elsewhere of publication or has been previously published. (this restriction does not apply to abstracts published in connection with scientific meetings.)
4. Statement regarding conflicts of interest specially in articles on Drug trial.

Title page (Page 1) : This should contain the Title, Names of all the Authors written in continuation. Name(s) of Institution(s) they are affiliated to. Names (first name, initial or middle name followed by surnames of all the authors (without degrees or diplomas). Name and full location of the department/ institutions/ laboratory where the work was performed.

The name, telephone number, FAX number, E-Mail and postal name and address of the corresponding author and acknowledgment of financial support if any.

Structured Abstract (Page 2) : Should be typed on a separate sheet.

The abstract (250 words maximum) should be structured and divided into sections namely Background / Rationale, Methods and Results, Discussion and Conclusions.

Also, provide 3-5 key words, terms from the medical subjects headings (MeSH), list of Index Medicus should be used.

Text (Page 3 onwards) : The text should be divided into Introduction, Methods, Results and Discussions.

Give generic rather than trade names of drugs. Avoid the use of full stops in between abbreviations (TMT not T.M.T.)

Introduction : The introduction should state why the study was carried out and what where its specific aims.

Methods : These should be described in sufficient detail to permit evaluation and duplication of the work. This section may be divided into subsections, if required. Ethical guidelines followed by the investigations should be described. Statistical details should be provided where applicable.

Results

Discussion : Should consist of review of literature and relate the major findings with other publications.

References : In Vancouver style and should be numbered consecutively in the order in which they first appear in the text.

Labeling citation : References are numbered consecutively in order of appearance in the text - they are identified by Arabic numerals in parentheses (1), square brackets [1], superscript¹, or a combination[1].

Format of citations : Different formats exist for different types of sources, e.g. books, journal articles etc. Author names are abbreviated to at most two initials.[10] Although Citing Medicine does not explicitly mandate merging initials (e.g. “R. K.” would be merged into “RK”), the examples used throughout the book do.

Journal Articles

Standard Journal Articles

- Leurs R, Church MK, Tagliatela M. H1-antihistamines : inverse agonism, anti-inflammatory actions and cardiac effects. *ClinExp Allergy*. 2002 Apr; 32(4):489-98.

As an option, if a journal carries continuous pagination throughout a volume (as many medical journals do), the month and issue number may be omitted :

- Thomas MC. Diuretics, ACE inhibitors and NSAIDs the triple whammy. *Med JAust*. 2000; 172:184-185.

If there are more than six authors, the first six authors are listed followed by “et al.” :

- Guilbert TW, Morgan WJ, Zeiger RS, Mauer DT, Boehmer SJ, Szeffler SJ, et al. Long-term inhaled corticosteroids in preschool children at high risk for asthma. *N Engl J Med*. 11 May 2006; 354(19):1985-97.

Note, however, that the NLM lists all authors for articles.

As an option, a unique identifier from a database may be added to the citation :

- von Itzstein M, Wu WY, Kok GB, Pegg MS, Dyason JC, Jin B, et al. Rational design of potent sialidase-based inhibitors of influenza virus replication. *Nature*. 1993 Jun 3;363(6428):418-23. Cited in PubMed; PMID 8502295.

Articles not in English

As per journal articles in English :

- Forneau E, Bovet D. Recherches sur l’action sympathicolytique d’un nouveau dérivé du dioxane. *Arch IntPharmacodyn*. 1933;46:178-91. French.

The NLM adds an English translation of the title enclosed in square brackets right after the title. The language is specified in full after the location (pagination), followed by a period.
